The application for participating in the tender shall be submitted with relevant documents regarding the identity of the tenderer and the co-operative society in the Office of the undersigned by 10.30 A.M. on 28.03.2018.

Tender documents duly filled up shall be dropped in the tender box of this Office before 1 P.M. on 28.03.2018.

The tender documents shall be opened in presence of the tenderers, who shall remain present, by the above-referred Committee at 1.45 P.M. on 28.03.2018.

Tender would be accepted by the undersigned by 2 P.M. on 28.03.2018 as per the decision of the Committee. Supply Order would be given instantly to the eligible and selected co-operative society.

The Committee and the Secretary D.L.S.A., Uttar Dinajpur reserves the right to accept or reject or cancel any or all prequalification documents without assigning any reason whatsoever and to remain not bound to accept the lowest rate without assigning any reason thereof.

The successful co-operative agency shall be bound to deliver the computer within the following price range positively by the forenoon of 29.03.2018 failing which the supply order in favour of the co-operative society shall be treated as cancelled and it shall be open for the Committee and the undersigned to issue the supply order in favour of next eligible co-operative society or to cancel the tender process, as the case may be.

The successful tenderer co-operative society shall be bound to supply the computers and all its components in good condition and to make good any fault therein at its own cost. It shall also be bound to render necessary services with regard to the article within the warranty period covered.
