The tender documents duly filed in all respect to this office shall be dropped in the tender box of this office before 2:00 P.M. on 20.03.2018. Any sealed cover of tender received after the date & time set forth will not be entertained and will be returned unopened. This D.L.S.A. does not take any responsibility for any delay.

Earnest money 2% (two percent) on the tender amount in the shape of DD (Demand Draft)/ bank cheque on any Nationalized Bank/ scheduled bank shall also be required to be submitted along with tender documents in a sealed cover.

The intending tenderer shall have to submit valid PAN issued by the IT Department Government of India, I/Tax, Professional Tax, valid 15-digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act, 2017 along with satisfactory completed as a prime agency during the last 5 (five) years prior to the date of issue of this Notice at least one work of same nature under authority of State/ Central Government undertaking/ Statutory Bodies and having at least 50 % (fifty percent) credential of the estimated amount put to tender. Tax invoice(s) need to be issued by the supplier for raising claim under the contract showing separately the tax charged in accordance with the provisions of GST Act, 2017.

Rate should be quoted in % (Percentage) in respect of project cost.-The rate will include all taxes etc.

The tender documents will be opened on 20.03.2018 at 4:00 P.M. in presence of tenderers in the chamber of Secretary, D.L.S.A., Uttar Dinajpur.


